B. Approving the 2025 Goals

Kevin Mosher spoke about outsourcing the nonprofit grant program to an outside organization and clarified that the assembly was not being considered for this task.

Commissioners discussed goals such as suicide prevention, food security, and supporting underrepresented populations, referencing examples from Anchorage and Juneau. They agreed on assigning a lead person for each goal and presenting recommendations to the Assembly by year-end.

They focused on broadening mental health efforts, keeping suicide prevention central while emphasizing post-intervention support, grief processing, and stigma reduction. Discussions also covered the city's role in mental health, consistent messaging, a potential marketing campaign, and partnerships with nonprofits for awareness. They considered the city's social media policies and the idea of hosting an annual event to promote resources.

The Commission decided to focus on two goals for 2025: health and racial equity, and mental health and suicide prevention/postvention. They discussed the challenges of taking on three goals given limited capacity and time constraints

Duncan moved to approve the 2025 HNHS Goals to include health and racial **equity**, **and mental health and suicide prevention/postvention**. **Motion passed 6-0 by a roll call vote**.
