APPROVAL OF MINUTES IV.

A. February 11, 2025

Marx moved to approve the February 11, 2025, meeting minutes. Motion passed unanimously by a voice vote.

V. **REPORTS**

Members: Poulson and Hughey commented on the progress on the Sawmill Creek project.

City Staff: Kevin Knox, Parks, and Recreation Coordinator reported on after-school programs and spoke about the new membership cards that had been introduced for punch passes and monthly memberships. Connor Dunlap, Facilities Division Supervisor, reported that the renovations of the planting beds at Harrigan Centennial were underway, with plant stock expected to arrive soon. He mentioned that a full-time position had been posted in the Parks and Grounds Maintenance Division, and a summer seasonal temporary position would be posted soon.

Other(s): Ben Hughey, Sitka Trail Works reported that over \$40,000 was raised for a trail crew in town to make up for terminated service.

VIII. NEW BUSINESS

B. Presentation by Lisa Busch on increasing art in City Parks

Lisa Bush from the Fari Weather Cove emphasized its ability to inspire, foster engagement, and positively impact the quality of life for both residents and visitors. She noted the community's existing art outlets and public art installations but expressed a desire to do more. And suggested that public art could beautify unsightly spaces and reflect the community's values, using examples from other communities. She also mentioned the economic benefits of public art, citing a study that showed visitors spent 20% more when public art was present.

The committee discussed forming a subcommittee to evaluate public art installations, focusing on location selection, approval, and funding through grants or visitor tax money. They agreed to create a list of potential sites for public comment and considered involving the city. They also acknowledged the need for maintenance and the temporary nature of the installations.

C. Commercial Land Use Permits

1. UnCruise Adventures

Marie Schelton, the owner, gave a briefing on her business activities.

Poulson moved to recommend approval of the commercial recreational land use permit as requested by UnCruise Adventures (subject to the proposed conditions of approval) and hereby make the required determinations regarding this use as listed in SGC 14.10.030(B)(1-3). Motion passed unanimously by voice vote.

2. Beyond the Dock Tours

Kealoha Harmon, the owner, gave a briefing on her business activities. She mentioned her tours were small private groups, with a maximum of six guests.

Black moved to recommend approval of the commercial recreational land use permit as requested by Beyond the Dock Tours (subject to the proposed conditions of approval) and hereby make the required determinations regarding this use as listed in SGC 14.10.030(B)(1-3). Motion passed unanimously by voice vote.

3. Lone Eagle Resorts

Darryl Bouchard from Lone Eagle Resorts presented their plans for a 4-day, 4-night experience, with a maximum of 6 guests per boat. The committee expressed satisfaction with the enforcement of permits the previous year, which had led to a better experience for all parties involved. The Committee discussed the feasibility of this limit, considering the size of family groups and the need to stagger boat arrivals. And agreed to implement the condition to prevent overcrowding and manage the number of people in the small area.

Marx moved to propose the following conditions of approval: to limit the maximum group to 6 for Baranof Warm Springs Dock. Motion passed unanimously by voice vote.

Prussian moved to recommend approval of the commercial recreational land use permit as requested by Sound Sailing (subject to the proposed conditions of approval) and hereby make the required determinations regarding this use as listed in SGC 14.10.030(B)(1-3). Motion passed unanimously by voice vote.

4. Sitka Sunshine Kayaks

Black moved to recommend approval of the commercial recreational land use permit as requested by Sitka Sunshine Kayaks (subject to the proposed conditions of approval) and hereby make the required determinations regarding this use as listed in SGC 14.10.030(B)(1-3). Motion passed unanimously by voice vote.

5. SEAK Adventures, LLC

Charlie Jordan provided a brief overview of his business activities.

Marx moved to recommend approval of the commercial recreational land use permit as requested by Alaska Luxury Tours (subject to the proposed conditions of approval) and hereby make the required determinations regarding this use as listed in SGC 14.10.030(B)(1-3). Motion passed unanimously by voice vote.

D. Amending Title 14 "Streets, Sidewalks, and Public Places" of the Sitka General Code by amending Chapter 14.05 "Public Use of Parks and Recreation Facilities, Land, and Trails

Knox provided an overview of the outdated code governing public use of parks and Recreation facilities. Several factors prompted the update, included: Outdated regulations, expanded responsibilities, need for modern administration, increased usage, and administrative clarifications The Parks and Recreation Committee recommended adopting the changes to the code, including moving Tom Young Cabin reservations online and transferring responsibility from Public Works to Parks and Recreation. Prussian thanked staff their hard work on this item.

Prussian moved to recommend the revised ordinance to the Assembly for adoption. Motion passed unanimously by a voice vote.

E. Parks and Recreation Facilities Fee Schedule

Knox provided a background on the most current fees. Hughey question how do the fees compared to the Hames Center. Prussian wondered about the potential gift options for passes.

Prussian moved to recommend to the Assembly to proceed with the adoption and Implementation of this fee schedule. Motion passed unanimously by a voice vote.

IX. ADJOURNMENT

The next meeting would be on April, 2025, at noon in Harrigan Centennial Hall. Hearing no objection, Chair Hughey called the meeting adjourned at 1:00 p.m.





Bear Paw Charters LLC is owned by William (Bill) West. Chrystal Rozander is organizer for the LLC and also Bill's wife.

Home port is Sitka, AK and anticipate the bulk of our charters to depart and drop in Sitka unless otherwise arranged. Bear Paw is 90' in length, steel built with aluminum superstructure and is a 12 passenger vessel with a crew of 3, minimum 2.







In the field, guides will incorporate "Leave No Trace" methods for all activities including trash disposal and personal waste disposal on the National Forest. Principles and techniques of "Leave No Trace" outdoor behaviors appropriate to Southeast Alaska will be discussed, including low-impact methods of human waste disposal and the "Pack it in - Pack it out" policy. All Trash will be carried out. Guest will be able to use Rest room facilities at our Lodge before departing to their Baranof outing or we also have a full bathroom at our Spa Cabin in the Baranof Townsite.

Other protection plans: Stewardship is a high priority for our company and we continually strive to maintain the resources. We only allow small groups to land on any river system or shoreline landing at a time. We also give mandatory rest days between usage to control our impact on these systems in all areas we use. All guests are informed about their tour on National Forest lands, resources, recreational opportunities, and its special wild places along with a briefing of general safety and bear safety procedures With per-orientation, our guests are informed about the adventure they have chosen for the day including "pack it in- Pack it Out" policies and orientation of BWL recycle and waste program with the location of proper receptacles. Guests will be fully outfitted with all the proper outdoor gear such as boots and foul weather gear and fitted for waders at the lodge and camp. Sun block and bug repellent and safety glasses for fishing are checked and issue before departure.

All guests are briefed on general safety, bear safety procedures and gun safety through pre-trip information, post arrival briefings and before shoreline and stream landings.
- 2. The hazards of every trip will be made known to every participant. Prospective clients will be screened to insure that they are qualified to make the trip in question.
- 3. All participants will be given specific instructions concerning boat handling and safety procedures. No one will be permitted to depart until everyone in the party is ready and orientated with a pre-trip safety talk. All members of the group will be accounted for at all times.
- 4. All members of the party, including the outfitter and employees will wear an approved floatation device when ever they are in the open skiffs & Rafts. All charter boats have labeled easy excess able lockers for storage of Type I life jacket for all passengers on board.
- 5. A procedure for the evacuation of a seriously injured person will be established, and made known to all employees. Sitka USCG rescue station and Helicopters are near by & are monitored on VHF Channel 16; 24 hour a day. Guest will also be briefed on our Lost and overdue client procedures and emergency and evacuation procedures.
- 6. If onsite water is to be used, measures will be taken to prevent contamination or pollution of such supplies. Unless tested, water will be treated, pumped through our industrial filter located at the source of our domestic water line. Bottled water & use of portable water filters on outings.
- 7. Sanitation in food handling is an important safety consideration and will be given continuous attention in the accordance with State & Federal health Codes.
- 8. Gas or butane stoves will be maintained in accordance will local ordinances and Underwriter's Laboratories standards.

If the holder wants this permit to be renewed, the holder must notify the authorized officer in writing at least 6 months before this permit expires. The decision whether to issue a new permit to the holder is at the sole discretion of the Forest Service. The authorized officer may prescribe new terms and conditions when a new permit is issued.
- **E. AMENDMENT.** This permit may be amended in whole or in part by the Forest Service when, at the discretion of the authorized officer, such action is deemed necessary or desirable to incorporate new terms that may be required by law, regulation, directive, the applicable forest land and resource management plan, or projects and activities implementing a land management plan pursuant to 36 CFR 218.
- **F. COMPLIANCE WITH LAWS, REGULATIONS, AND OTHER LEGAL REQUIREMENTS.** In exercising the rights and privileges granted by this permit, the holder shall comply with all present and future federal laws and regulations and all present and future state, county, and municipal laws, regulations, and other legal requirements that apply to the permit area, to the extent they do not conflict with federal law, regulation, or policy. The Forest Service assumes no responsibility for enforcing laws, regulations, and other legal requirements that fall under the jurisdiction of other governmental entities.

THIS PERMIT IS ACCEPTED SUBJECT TO ALL ITS TERMS AND CONDITIONS.





Guests depart the Lodge from the floatplane dock in Angoon via boat; travel across Chatham Straight (possible stop at Hidden Falls Hatchery); and then head south to the Warm Springs. This is trip is generally about a 45minutes – 1.5-hour boat ride depending on weather and wildlife. Once they arrive at the Baranof Warm Springs Dock – guests and a guide will disembark and hike up the trail to the lake for a shoreline picnic (if they haven't already eaten on the boat). Guests will then head to either the natural warm springs or the Grotto to soak, or they will head down to the bathhouses to soak. Guide to Guest Ratio – 1:6 (maximum); Expected time on shore – approximately 1.5-3.5 hours.

Guests may bring a couple of kayaks to paddle around the base of the falls, but this is not something we advertise or promote.

B. Restroom Accommodations, Litter Control, Emergency Evacuation and Clientele Safety Briefing

The boats that are used to transport our guests all have either a stand-up head or under-seat head on board. Restroom accommodation would be expected to be taken care of on board the vessel. We have adopted the "Leave No Trace Seven Principles" (www.lnt.org). Regarding disposing of waste, we follow the mantra of "Pack it In, Pack it Out." We pack out all trash, left-over food and litter. Emergency Evacuation would be done via vessel or floatplane as necessary. The clientele safety is primarily centered around bear safety and awareness (See attached). We also express the necessity of taking it slowly and easy on the hiking trail, but especially in the Grotto when traveling to the Warm Springs. All clients undergo a safety briefing upon boarding the vessel. This includes but is not limited to the basic use of the VHF and Coast Guard Channel 16; life vests, flares and First Aid Location on the boat.

C. Schedule of fees/charges to clients, etc.

The excursion to the Baranof Warm Springs is considered a guided activity that is included in the All-Inclusive Packages and Rates that guests purchase to stay with us. There is no additional fee or surcharge for this excursion.

Safety Plan for Guests at Favorite Bay Lodge

I. Introduction At Favorite Bay Lodge, guest safety is our top priority. This safety plan outlines guidelines and procedures to minimize risks while ensuring a safe and enjoyable experience both on boats and on shore.

II. General Boating Safety

1. Life Jackets:

- All guests must wear a U.S. Coast Guard-approved life jacket while on the boat.
- o Guides will provide proper fitting and ensure secure fastening.

2. Emergency Equipment:

- Each boat is equipped with emergency flares, radios, and first aid kits.
- Guests will be briefed on the location and use of emergency equipment before departure.

3. Weather Awareness:

- Captains will check weather conditions before every trip and adjust schedules accordingly.
- Guests should be prepared for sudden weather changes and wear appropriate clothing.

4. Communication:

- Boats are equipped with VHF radios to maintain communication with the lodge.
- In case of emergency, guests should follow crew instructions and use the radio if necessary.

5. Safe Boating Practices:

- Always remain seated while the boat is in motion.
- Keep hands and feet inside the boat at all times.
- Avoid sudden movements that could affect stability.

III. Shore Safety

1. Stay with Your Group:

- Guests must always stay with their guide when onshore.
- Straying from designated paths increases risks from wildlife and difficult terrain.

2. Footwear and Gear:

- Wear sturdy, waterproof boots suitable for uneven and slippery surfaces.
- Carry rain gear and layered clothing to adapt to changing conditions.

3. Emergency Response:

- Guides carry first aid kits and are trained in emergency response procedures.
- o In case of injury or distress, follow guide instructions immediately.

IV. Bear Safety

1. Understanding Bear Behavior:

- Southeast Alaska is home to both black bears and brown bears (grizzlies).
- Brown bears are generally larger and more aggressive, while black bears tend to be more reclusive.
- A bear standing on its hind legs is often trying to get a better view or scent and is not necessarily a threat.

2. General Safety Measures:

- Stay in groups and avoid wandering alone in bear-prone areas.
- Make noise by talking loudly, clapping, or calling out to alert bears of human presence.
- Carry bear spray and know how to use it properly.

3. Food & Attractant Management:

- Do not carry or consume food in areas with high bear activity.
- Dispose of all trash properly and never leave food scraps behind.

4. Encounter Protocols:

- If you see a bear at a distance, stop and assess the situation before slowly backing away.
- o If a bear notices you, remain calm, speak firmly, and do not run.
- If a bear approaches aggressively, prepare to use bear spray when it is within range.
- If a brown bear makes physical contact, play dead by lying on your stomach with your hands covering your neck.
- If a black bear attacks, fight back aggressively by targeting its face and nose.

5. Emergency Response:

- Guides are trained to handle bear encounters and will lead guests to safety if necessary.
- All bear encounters are reported to the U.S. Forest Service and relevant authorities.

V. Emergency Response Plan

1. Medical Emergencies:

- In the event of an injury or medical condition, first aid is administered, and emergency services are contacted if necessary.
- Vessels are equipped for emergency transport to the nearest medical facility.

2. Man Overboard Protocol:

- Immediate action is taken to retrieve individuals from the water.
- o The boat captain and crew are trained in retrieval techniques.

3. Lost Person Protocol:

 If a guest becomes separated from the group, a coordinated search is conducted using available communication devices and local authorities if needed.



Sitka Parks and Recreation Committee,

Good afternoon! I am writing you in hopes of receiving a commercial land use permit for my company Alaska Bound Charters owned by Undaunted Yacht Management LLC. We are a small charter operation based out of Petersburg, Alaska. My husband Jim and I are Petersburg residents and have recently started operating charters. We charter our vessel, Dauntless, for 8 day 7 night trips (occasionally we have custom trips the vary in length but that is our typical trip duration). Guests rent the yacht and all the activities aboard Dauntless or via skiff/kayak for an all inclusive weekly amount. Sitka is a little off our beaten path but we do try to make it over there 1-2 times during our summer season and we hope to eventually incorporate a spring season in Sitka into our schedule. I would love to be able to take our guests to Baranof Warm Springs and/or Goddard Hot Springs during our summer season (May-Oct). We typically have 6 or less guests per week and would have 1-2 crew member accompany them. We would typically stop once per week (If the guests have an interest and are fit enough to do the hike). We anchor out and bring guests to shore via our skiff and typically stay for 1-3 hours. Our stops have always occurred between the hours of 9 am-5 pm. Most times its just a short stop on our way to somewhere else, so a lot of times we aren't even anchoring overnight in the bay.

We would love to be able to add some Sitka spring trips into our calendar starting in 2026 so it would be nice to have access to be able to take guests to Goddard hot springs as well as hike some of the trails around Sitka. Again it would be 6 or less guests with 1-2 guides and where we would go would depend on the weather, interests of the guests and fitness/skill level. We would not have any motorized vehicles and would pack out anything we pack in. Jim and myself are both wilderness first responder trained and all of our guides are first aid certified. We have our first aid kit onboard Dauntless provisioned by a Doctor annually and try to include all the basics to be self sufficient (AED, Splint, Bandages, tourniquet, etc.).

When venturing into the wilderness we always send the guests with a guide that is trained in bear safety as well as versed in proper trail etiquette and local knowledge. We have handheld VHF's as well as satellite GPS devices. Our goal is to showcase this beautiful place we get to call home as well as educate our clients on SE Alaska. We strive to leave no negative impact anywhere we visit and seek to improve the area. Our goal is to always be good stewards of the land.

Thank you for considering Alaska Bound Charters/ M/Y Dauntless for a Sitka Commercial Land Use permit for our upcoming 2025 season! Please do not hesitate to reach out with any questions or if I can provide any clarifying information.




Wilderness Adventure Tours

1. All location(s) where the tour(s) or event(s) will be offered (including a map):

The tours will be offered at Baranof Lake Trail which is land by the State of Alaska and trail managed by Alaska's Department of Natural Resources. The Boat Company's guests access the trail via the dock and boardwalk owned by the City and Borough of Sitka.





2. Detailed explanation of activities, guide/client ratio, routes/locations, schedule, stops, days/hours of operation, estimated number of participants/customers.

a. Explanation of Activities:

The main activities that guided guests participate in at Baranof Warm Springs occur outside of the City and Borough's recreation site. Guests use the City dock and boardwalk mostly for the purpose of accessing the State of Alaska's Baranof Lake Trail and Forest Service owned lands at Baranof Lake. The City and Borough of Sitka permit is necessary to access these areas.

b. Guide to Client ratio:

Boat Company hiking tours typically have one guide per five guests. However, the actual ratio varies depending on location and guest interests as we have offered hiking tours throughout northern Southeast Alaska for over forty years. Often our guests have different fitness levels and disperse in groups of 5 with one guide per group, but guest groupings may also include families that prefer to enjoy hiking tours in slightly larger groups. The State of Alaska does not mandate a specific guide/client ratio on the upland trail and federal regulations apply a 20-person maximum group size limit which includes guides on Forest Service owned lands at Baranof Lake.

c. Routes/Location

Company mother vessels are U.S. Coast Guard inspected overnight passenger vessels approximately 150' in length. Each vessel typically carries between 20 and 24 passengers. Baranof Warm Springs is located along the route which the two mother vessels follow during week-long cruises between Sitka and Juneau. Occasionally, the vessels may anchor in Warm Springs Bay and guides and guests may use the boardwalk primarily for a short hike to the eastern shores of Baranof Lake or to access the warm spring pools. The mother vessel anchored some distance away from the city dock will dispatch 19' skiffs operated by licensed captains that drop guests and guides off at the main dock. Occasionally, one or more skiffs will remain tied alongside the float for short periods of time while clients are ashore.

d. Schedule, stops, days and hours of operation

The Boat Company does not have an established schedule for using this location. The Boat Company does not set its itinerary until the beginning of a trip because captains and crew tailor activities to each client group each week after reviewing projected weather conditions and communicating with other small cruise tour operators through an online platform used to avoid spatial and temporal overlaps. Because of The Boat Company's cruise routes, client visits ashore occur on a Tuesday, Wednesday or Thursday. The Boat Company's 2025 operating season will begin the third week of May and end after the first week of September. Duration of a visit ashore will generally be less than two hours and typically be daylight hours between 9:00 a.m. and 4:00 p.m.

Use patterns since the resumption of normal operations (*i.e.* post-COVID-19 pandemic) have been 3 stops in 2022, 13 stops in 2023 and 4 stops in 2024. In 2024 all of the stops occurred during the "shoulder season" *i.e.* in May and June. It is likely that The Boat Company may mostly or exclusively make shoulder season stops in 2025 because the increased use of this location in July and August by large private or chartered yachts makes the location less attractive for ecotour operators and guests.

e. Estimated number of participants/customers

Actual recent use was 53 guests in 2024, 203 guests in 2023 and 59 guests in 2022. The number of guests using the City and Borough dock to access upland recreational activities per stop generally ranged from 10 to 20 guests. 2025 participants could range between 50 and 200 guests. As previously noted, current trends toward increased use of this location large private or chartered yachts in July and August make it likely that there will be fewer stops as in 2022 and 2024.

f. Plans for restroom accommodations, litter control, emergency evacuation, & clientele safety briefing; training requirements/standards of personnel conducting transport and tour activities.

Visits will be of short duration and will not require restroom accommodations ashore. Skiffs and skiff captains will be available at any time to shuttle clients back to the mother vessel and onboard restroom accommodations.

The Company operates under "Leave No Trace" guidelines and guides and clients will be instructed to carry out all refuse.

Plans for emergency evacuation, clientele safety briefing and training requirements/standards of personnel conducting transport and tour activities are included in Attachment B, Safety Plan.

g. A schedule of fees and charges to customers and a description of any collection, disbursement, royalty, commission or similar arrangements with others, including tour brokers, agents, or cruise ship companies.

ATTACHMENT B: SAFETY PLAN FOR OFF-VESSEL ACTIVITIES / SHORE EXCURSIONS

First Aid, Safety & Emergency Training

All skiff operators have a U.S. Coast Guard license. All crew members are certified in CPR and First Aid. During pre-season training and orientation, all crew members attend an on-board 1st Aid/CPR training course, including instruction on avoiding/treating hypothermia. Many crew members have prior training and experience considered in the development of emergency response strategies. The Boat Company seeks to place at least one individual on board each vessel who has receive a higher level of training than 1st Aid/CPR, such as Wilderness First Responder or Wilderness EMT.

Pre-season training in normal Southeast Alaska operating areas includes opportunities for both on-shore and on-the-water orientation. Videos and other instructional materials will be provided and all guides are expected to familiarize (or re-familiarize) themselves with, at minimum, the following safety-related subjects: bear safety, trail/off-trail hazards, skiff handling with passengers, safe approach distance to tidewater glaciers, noxious/poisonous plant identification, punctures/infections from handling fish, basic kayaking competence, hand-held radio communication procedures and weather preparedness.

MIST COVE and LISERON are USCG inspected passenger vessels. Licensed officers and crew are required by Federal law to regularly conduct emergency training and drills for fire, man overboard, abandon ship and response to distress calls. Federal regulations require that Captains file a detailed report on each drill in the ship's Logbook upon completion of the drill or training exercise. Vessel Logbooks shall be periodically reviewed in-season by a senior company employee and checked for compliance with safety regulations.

Emergency Survival Supplies

- 1) Emergency survival supplies on each mother vessel are stipulated by their unique USCG Certificate of Inspection and shall include at minimum:
 - Life Rafts, inspected annually, with contents and auto-release per regulation
 - EPIRB (Emergency Position Indicator Radio Beacon), with auto-release
 - Flares, unexpired, per regulation
 - Fire Extinguishers, regularly inspected, per regulation
 - Life Vests, approved and in sufficient numbers/sizes, per regulation
 - Life Rings, throwable, two with emergency lights & lines, per regulation
- 2) Emergency supplies in skiffs shall include at minimum:
 - Flares, unexpired, per regulation
 - Fire Extinguishers, per regulation
 - Air Horn or other suitable noisemaker, per regulation

- Ditch Kit including bottled drinking water, matches, toilet paper, flashlight, first aid manual
- 3) Emergency supplies in guide packs shall include at minimum:
 - Bottled Water
 - Med Kit
 - Flashlight
 - 1 or 2 large heavy gauge trash bags

Communications Equipment and lost/overdue party procedures

Guides each have individual hand-held VHF radios, with batteries recharged each night if necessary. A VHF radio watch shall be maintained on board motherships at all times with scheduled check-ins whenever parties are out in skiffs or on shore. Guides conduct their activities in such a way as to remain in reasonably regular contact with other guides and/or with mother vessels. VHFs are also permanently mounted in all skiffs. Skiff radio output power is much greater than hand-held radio output power, so guides on shore also can relay communications through skiff operators in order to stay in touch with mother vessels. Each mother vessel also has a hand-held satellite telephone for use in emergencies.

If a group in a skiff or group on shore becomes disoriented and lost, but is otherwise safe and in VHF contact with the mother vessel, then the Captain must be immediately notified and take action to locate the party. As long as VHF contact is maintained, and the party is safe, the Captain shall have the discretion to choose a proper response strategy. If outside assistance is mobilized (i.e., US Coast Guard or local Search and Rescue Units) then senior company officials must be immediately contacted.

If a group in a skiff or on shore fails to return to the mother vessel at the expected time and/or fails to respond to VHF radio calls, then the Captain will respond as previously described, but must contact senior company officials immediately via sat-phone, cell phone or any other available means. In any instance where the safety of a lost/overdue group is not known, the assumption is that the group is at risk and onshore company officials must be informed and assist with implementation of a crisis communications plan.

Client Briefing and Bear Safety

Naturalists provide guests with an onboard bear presentation prior to the first shore-going activity of a cruise. Guides repeat the bear safety protocol when landing groups ashore in bear country. Guides keep groups together on trails, remain in the lead, watch for bear signs and never allow groups to string-out excessively along trails. Ecotour operators prefer to avoid bears during hiking, fishing and beachcombing activities and there is constant communication in the field about where bears are and are not present. Each guide carries an air horn and two cans of bear spray but do not carry firearms. There is always a "standby" skiff maintaining radio communications with onshore groups and available to shuttle a group away from an area when guides observe the presence of bears during onshore activities.

Bear safety practices also refer to keeping bears safe. Bear viewing opportunities are opportunistic and provided while on saltwater from a skiff or mothership using binoculars. Guides follow responsible bear viewing guidelines at all times. We avoid activities particularly in areas where bears are not habituated to people out of sensitivity to foraging bear needs for space along a grass flats or in a salmon stream. When a bear becomes aware of a group's presence, guides observe its behavior for signs of anxiety or irritation. If a bear approaches, it may be either curious or aggravated and the guide's response will be to yield to the bear and gradually (but decisively) move the group away from the area. Guides observing any aggressive or unusual bear behavior report to the vessel Captain, who shares the information with the other vessel Captain and other tour operators. If the behavior is extreme senior company officials will report the encounter to the US Forest Service and ADF&G. The Boat Company's

management and guides review and adhere to bear safety guidelines, including safe viewing procedures set forth in the Brown Bear Management Strategy:

- Always remain far enough away from the bear so that your presence, if noticed, does not affect the animal's behavior. The distance bears normally react to human presence is typically much greater than people assume. Use binoculars, spotting scopes, or other telescopic lenses to improve your view.
- Bears are wild animals and you are viewing them in a remote area. Be prepared. Review current agency information and brochures on protection and how to deal with close encounters.
- Always select a viewing position that does not make you vulnerable to a surprise approach by a bear.
- Never directly approach a bear.
- Avoid situations where your presence could startle a bear.
- Avoid viewing from obvious bear trails.
- Never allow bears access to human foods.
- There is safety in numbers, stay with your group.
- If seen by a bear, avoid moving. Even minor movements will encourage wary bears to leave.
- Never use a motorized vehicle or boat to try getting close to a bear.
- Never run from an approaching bear; if you move away do it in a slow, deliberate manner.
- Show respect and courtesy to other bear viewers. Conduct your viewing in a way that doesn't detract from their experience. Don't mix booze with bears.
- Think wind, wind, wind. When possible always approach bears, or areas where bears are likely to be, from downwind.
- The best bear viewing is usually in the early morning or evening. Shoreline viewing is usually better during low tides.
- Small groups are less likely to disturb bears and so more likely to have better viewing.

Boating Safety

All crew members exercise diligence in keeping themselves and their guests out of harm's way while on shore or out fishing. Routine safety precautions include, at minimum, the following:

Life Jackets

US Coast Guard approved Type 1 Personal Flotation Devices are stowed in each guest's staterooms and in deck lockers on each mother vessel for use in emergencies. More comfortable Type 3 life jackets in a full range of sizes are provided for use during normal off-vessel activities. Guides and guests must wear life jackets at all times when off-vessel and on-the-water. Guides may substitute float-coats or CO₂-inflatable vests according to preference. Each mother vessel's boarding and disembarking area is the boundary line beyond which life jackets are required. Life jackets may be removed only when a kayak or skiff is safely touching shore, or only when a guide/guest is safely back onboard the mother vessel. Flotation cushions, enough for all guests, are stored on board the mother vessels. These must be placed in skiffs before guests board in order to provide both comfort and additional safety.

Skiff & Kayak Safety

Only USCG licensed guides are authorized to operate skiffs with guests onboard. Guests are not authorized to operate skiffs. Guides shall not load skiffs beyond their fixed capacities of 7 persons total. All skiff passengers must remain seated when operating skiffs at high speed and while landing, docking, or coming alongside.

Two types of guest kayaking activities may be provided: near-vessel kayaking, and guided kayaking. Near-vessel kayakers stay within sight of the mother vessel and may be given general instructions on basic paddling safety according to a guest's individual experience. Guests are instructed to signal with a raised-paddle when in need of assistance. A kayak watch shall be maintained at all times on the mother vessel when near-vessel kayaking activities are taking place. Guided kayaking activities, on the other hand, may take place out-of-sight of mother vessels so long as a guide with a hand-held radio is among the paddlers. In all instances when paddlers are out on the water, a skiff shall be tied alongside the mother vessel and kept at-the-ready for dispatch in case of emergency.

Swimming Safety

Swimming is not allowed off mother vessels where the depth of water is often greater than 100 feet. Swimming activities may be provided by first guiding guests to shore in a skiff. Once on shore, shallow-water entry and exit is made possible for swimmers.

Shore & Fishing Excursion Safety Guidelines

Guides must not allow anyone in their shore excursion groups, including themselves, to take unnecessary risks. Steep and slippery terrain can be found nearly anywhere in Southeast Alaska, but vertical drop-offs can and must be avoided. Excessive risk-taking on shore by any crew member may constitute grounds for immediate dismissal. Guests are advised about paralytic shellfish poisoning and do not consume food onshore except for snacks or meals prepared on board the motherships.

Emergency and Evacuation Procedures

Emergency evacuation of one or more individuals in a shore party requires that the party make every effort to return to the mother vessel. If the severity of the emergency prevents returning to the vessel, then the maintenance of VHF communications between the shore party and the mother vessel becomes a priority.

Mother vessels have the communications equipment necessary for mobilizing outside rescue response units or medical assistance at the discretion of the Captain. Should one or more members of a shore party be deemed by the Captain to be in need of outside assistance, action shall be taken similar to that in case of a shipboard evacuation emergency, but with response units being directed to the site on shore by the Captain on board the mother vessel. Immediately upon initiating emergency evacuation procedures of any kind, the Captain shall, as soon as possible, contact senior company officials via sat-phone to report the emergency.







We offer weeklong adventure tours onboard Motor Vessel Alaskan Song. One of our weekly stops is Baranof Warm Springs. We offer a guided tour of the lake and natural warm spring pools. We take a maximum of 10 guests guided by a minimum of 1 guide. The tour starts at the dock where we disembark from our skiff. Then we proceed up the dock and fallow the board walk to the trail and up to the lake. Once at the lake the guests take a few pictures before we head back down the trail to the warm spring pools. This tour last between 1 and 3 hours depending on the guest's activity level.

We always spend the night anchored out in the bay and we will choose a time for the lake tour when the dock has an available spot for our skiff. Whenever possible we will choose a time when there are less people on the dock and in town. We have a strict leave no trace policy. Our groups will never leave trash on shore, all trash created will be carried back to Alaskan Song and stored until the end of the weeklong trip when we will dispose of it at either the Juneau or Sitka marina. Before we leave Alaskan Song for the lake tour, we brief all the guests on our leave no trace policy, safety while on shore and we make sure that all our guests and guides know there is no restroom facility on shore. Our guide or guides always carry a full suite of safety equipment including bear spray, handheld VHF radio, medical kit and personal EPRIB. The guide is required to check in with Alaskan Song every hour by VHF radio. All our guides are trained in basic first aid, CPR and we do an extensive wildlife safety training with all of our guides.

The rates for a 7-night 8-day trip on Alaskan Song start at \$40,000 for four guests and \$5,000 per additional guest. We pay a commission of 15% to any charter broker or travel agent who we work with.

All these tours are operated off M/V Alaskan Song a 1944 96' custom vessel with a 1984 15' Boston Whaler and a 2023 16' Stryker. All these vessels are registered with the state of Alaska, are fully insured and have all safety equipment up to date.

High Output Tours, LLC is asking for use of several municipal lands to conduct our tour operations. Are proposed areas are:

Tours

Our flagship tour, the Sitka Bike & Hike is a guided 3-hour tour which includes roughly 4 miles of biking and 2 miles of hiking. Guides accompany guests at all times. We bike from GPIP to Thimbleberry trail head or the Herring Cove trailhead, hike in and back, then bike back to GPIP. Throughout the trip guests learn about local flora, fauna, culture, and history. Max group for main route to thimbleberry is 14 guests:2 guides, Herring Cove 7 guests:2 guides.

The Tongass Rainforest Hike is one of our most popular tours typically taking place in the Starrigavan/Mosquito Cove area. However at times due to bear activity we look for alternative routes on the Cross Trail. It is a guided 3-hour tour designed for guests wishing to hike 2-4 miles. Group maxes range from 8-16 depending on what trails are utilized. 1:8 guide to guest ratio.

Our Advanced Bike Trip caters to the physically fit, experienced mountain biker. It typically is 18-26 miles of biking over the course of 4 hours and our route varies on the ability of the group. Our typical locations of use include HPR, SMC, the cross trail, Starrigavan Valley Logging Roads, Harbor Mountain Road. Sometimes, if we have a fast group will venture down the Green Lake Road or up Blue Lake Road as alternative routes. In 2024 we started using EMTB's (E-Mountain Bikes), these are class 1 electrically assisted trek mountain bikes that the rider must pedal to initiate the motor. Top speeds reached are 15mph. Motors are mainly utilized in climbing tough hills. This trip currently maxes at 10 guests, but we are lowering it to 8 in 2026. 2:10 guide to guest ratio.

Our **Guide's Choice Hike** is one of our newest additions, launching in 2024. This 4- hour guided hike is designed for more advanced hikers that prefer small groups and challenges. Our guide's get to pick their favorite trail(s) to use based on guests hopes, abilities, and weather. Options available to our guides for this trip are: Indian River, Herring Cove/Beaver Lake, Harbor Mountain, Gavan Hill, and the Cross Trail. This trip **maxes at 8 guests and has 1 guide**.

Our schedule aligns with the cruise season. Currently, 100% of our operation is with cruise passengers. A typical day of operation ranges from half an hour after docking to an hour before disembarking.

Typical days are Monday-Thursday, with scattered Friday-Sunday operations. Typical time frames are 8:00 AM – 4:00 PM but can be as early as 7:00 AM and as late as 8:00 PM but late times are highly unusual.

Transportation

Sitka Tours provides all transportation needs for High Output Tours. They utilize a number of shuttles, vans, and busses depending on the size of the group and destination.

Parking is not applicable as guests are transported and dropped off, then picked back up by usually a different bus driver.

Estimates

Max group sizes are listed above. Actual number of participants varies day to day, but range from 4-16 fitting in line with permit requirements.

We are anticipating operating 787 trips between these excursions between late April to late October. This at max capacity would mean roughly 8,000 guests.

Plans for restroom accommodations, litter control, emergency evacuation & clientele safety briefings

All guests are highly encouraged to use the restroom prior to departure from SSCT, HCH, or O'Connell Bridge. Trips range from 2-4 hours so most guests are able to utilized the restroom before departure and not need one again until returning. Depending on the trail/route, some guests use restrooms/outhouses at the trailhead or along the way; i.e. Whale Park, Starrigavan boat launch, Starrigavan estuary, etc.

All guides are trained on the federal regulations of trail impacts including "Leave No Trace Behind," a policy that High Output Tours has adopted as a priority. No Guests go off trail and no guests leave anything behind.

All guides 16 & older go through CPR/First Aid training/renewal prior to the start of the season. Several staff are also Wilderness First Responders, members of Search & Rescue, and/or volunteer firefighters.

High Output Tours has evacuation policies for both landslide and Tsunami emergency situations. Tsunami routes are established for each trail and landslide waterfront pickup locations are established (should roadways be inaccessible).

A safety briefing is provided at the beginning of each trip. This includes bear safety, bike training and rules of the road (for biking trips), and hike rules of the road. We also provide all routes utilized to SPD and SFD in case of emergency, so they know where we are operating in advance.

Training Requirements

All guides go through a 2-week training process prior to the start of the season, or their start date. This includes bear and wildlife safety training, survival training, CPR/First aid training, and Alaska Naturalist training. Amongst our staff we also have a dive instructor, 2 dive master's with drysuit certifications, 4 rescue divers, and a certified emergency first responder.


Schedule of Fees

High Output Tours is in contract with Royal Caribbean, Norwegian Cruise Lines, Holland America, Princess, Seabourn, Oceania, Reagent Seven Seas, Celebrity, Disney Cruise Lines, Carnival, Carnival UK, and Silver Seas. All tours are sold through each cruise line either in advance or on board. We are paid within 30 day of service. We receive \$40-95/per guest depending on the tour participated in.

We have permits through the USFS and the State of Alaska in addition to this potential one. We pay the USFS \$5/guest and the State \$2/guest.

We pay Sitka Tours \$9/passenger for our transportation.

We also have many partnerships with other local Sitka businesses that we pay a per person fee to that ranges from \$5-10, depending on what tour.

I. Introduction

High Output Tours (HOT) is dedicated to delivering high-quality, adventure-based experiences in Sitka, Alaska. This **Standard Operating Plan (SOP)** outlines our operational procedures, ensuring safety, environmental protection, and compliance with relevant federal, state, and local regulations. Our tours primarily operate on Tongass National Forest lands, State lands, CBS lands, and adjacent marine areas, focusing on **biking**, **hiking**, **culinary**, **WaveRunner**, **snorkeling**, and **pedal pub tours**.

II. Services Provided

A. Tour Activities and Locations

Advanced Biking Tours

- Locations: Green Lake, Medivijie Lake, Harbor Mountain, Cross Trail, Starrigavan Valley, HPR, SMC, Blue Lake.
- o Max Group Size: 8 guests per tour, 2 guides.
- Focus: Scenic and adventure biking with interpretive stops.

Bike & Hike Combination Tours

- Locations: SMC multiuse pathway, Thimbleberry/Heart Lake.
- Max Group Size: 14 guests per tour, 2 guides.
- Focus: Combination of biking and guided hikes to scenic locations.

Tongass Hike

- Locations: Mosquito Cove, Starrigavan Estuary, Ben Grussendorf Muskeg Trail
- o Max Group Size: 16 guests per tour, 2 guides
- o Focus: Naturalist interpretation

Guide's Choice Hike

- Locations: Trail varies per tour between: Herring Cove/Beaver Lake, Indian River, Cross Trail, Harbor Mountain, and Gavan Hill.
- Max Group Size: 8 guests per tour, 1 guide.
- o Focus: Flexible and unique outdoor experiences.

Culinary & Art Tours

- Locations: Local food venues and art studios in Sitka.
- o Max Group Size: 25 guests per tour.
- Focus: Showcasing Sitka's local flavors and artistic community.

Pedal Pub Tours

- Locations: Downtown Sitka.
- Max Group Size: 14 guests, 1 guide/driver.
- o Focus: Fun, social, and interactive pedal-powered experiences.

Snorkeling Tours

- Locations: Magic Island.
- Max Group Size: 10 guests per tour, 2 guides.
- Focus: Marine ecosystem exploration with safety instruction.

Waverunner Tours

- Locations: Waterfront and open water areas near Sitka.
- Max Group Size: 6 guests per tour (3 machines), 3 guides (2 machines)
- Focus: High-energy water exploration with wildlife viewing.

B. Operating Season

- Summer Season: Mid-April through October.
- · Winter Season: December through February.
- Training Period: April (2 weeks) before cruise season.
- Annual Summer Tour Estimate: 1600-1700 guided trips based on demand.
- Annual Winter Tour Estimate: 25-100 guided trips.

III. Safety Procedures

A. General Safety Protocols

Pre-Tour Briefing

- Overview of potential hazards: terrain challenges, weather conditions, wildlife encounters.
- Emergency procedures explained.
- Equipment check and proper use instructions.

Equipment Safety

- Regular maintenance of bikes, waverunners, snorkeling gear, and pedal pubs.
- Guests fitted with appropriate safety gear (helmets, life jackets, wetsuits, etc.).

Lost & Overdue Guest and Employee Procedures

o Prevention Measures:

- Small group sizes to maintain guest awareness.
- Pre-tour briefing on staying with the group and emergency protocols.
- Designated meeting points for regrouping if separated.

o Immediate Response for a Lost Guest:

- Conduct headcount and confirm the missing guest.
- Notify base operations with last known location.
- Search the immediate area and check meeting points.
- Contact the missing guest if they have a phone.
- Escalate to local authorities if not found within 15-30 minutes.

Immediate Response for an Overdue Employee:

- Attempt contact via call, radio, or satellite messaging.
- Check last known location and itinerary.
- · Dispatch a nearby guide to investigate.
- Escalate to authorities if no response within a designated timeframe.

Emergency Communication

- o Primary: Cell phone.
- Secondary: VHF radio (remote areas) and satellite communication.
- o Emergency Contact: 911, Alaska State Troopers, Coast Guard (for marine incidents).

Emergency Response & Evacuation

- Call 911 or VHF marine channel 16 for emergency assistance.
- Coordinate with Fire Department for search and rescue if needed.
- Evacuate guests via safest route available.
- For landslides, move guests to higher ground or designated safe zones.
- o Guides are trained in CPR, first aid, and emergency response procedures.

IV. Bear Safety Procedures

Guest Education

- Behavior in bear country: avoid running, store food properly, travel in groups.
- Use of bear spray and safe disposal of waste.
- Guides carry bear deterrents (bear spray and/or noise deterrents).

Encounters & Response

- Distant Sightings: Observe from a safe distance.
- o Close Encounters: Maintain calm, slowly back away.
- Aggressive Bears: Use deterrents if necessary, retreat safely.

V. Incident Reporting

· Reportable Incidents:

- Death, permanent disability, life-threatening injuries.
- Structural or mechanical failures affecting safety.
- Search and rescue operations.
- Significant property/environmental damage (e.g., landslides, flooding, fire).

Timeframe for Reporting:

- Verbal Report: Within 24 hours.
- Written Report: Within 7 days.
- Guides complete an internal incident report form on scene and turn in as soon as possible.

VI. Gratuity Policy

- Voluntary Gratuities: Not included in the tour price.
- Complimentary Trips: No expectation of gratuities.
- . Encouraging Tipping: Guides may explain that gratuities are appreciated but never required.

VII. Environmental Protection

Leave No Trace Principles:

- Pack out all trash and waste.
- No cutting of vegetation or altering trails.
- Use designated restroom facilities where available.

Waste Disposal:

- Wag bags for remote locations/emergencies.
- Pack out all human waste where necessary.

IV. Wilderness Stewardship & Guest Education

Guest Education on Wilderness Values:

- Emphasizing conservation principles and legal protections for designated wilderness areas.
- Discussion on minimizing human impact, preserving solitude, and allowing natural processes to shape the experience.
- Encouragement of non-motorized, low-impact activities while following Leave No Trace principles.
- Interpretation of natural features, historic sites, and cultural heritage unique to the Tongass National Forest.

Guidelines for Guides & Guests:

- Group Size: 4-16 people (depending on trail).
- Ethical Wildlife Viewing: Maintain safe distances from wildlife.
- No Site Alterations: Use existing campsites and natural features.
- Respect for Other Users: Maintain distance from other forest visitors to preserve solitude and minimize human impact.

V. Compliance & Wilderness Management

Compliance with Federal and Local Laws:

- Permitted under Tongass National Forest Special Use Authorization.
- o Compliance with Leave No Trace and USDA Ethical Wildlife Viewing guidelines.
