I really don't have any complaints in regards to the cameras. They are very useful for criminal prosecution; however, even more useful for protecting the city against frivolous complaints and law suits. They are a great tool for protecting officers while also holding those that need it accountable for their actions. The only negative aspect to them is the cost.

I used to work with North Slope Borough Police Department out of Barrow. We started using axon body cameras back in 2014, they were a tremendous asset and held up well in the cold.

The older models used to be affected by weather (rain), but that isn't the case any more. The cost comes from digital storage but that's expected. All in all, we're staying with Axon and we don't intend to move to any other brand.

Hi Gail,

The Kodiak Police Department began experimenting with body cameras about 10 years ago. After some trial and error, we ultimately decided to get Axon body cameras. We used the Axon Flex 2 first because the camera is mounted near the head and the thought was it could provide a better recording from an officer's perspective (which we now know is an incorrect description of body cameras). The additional connections, however, caused several failures due to rain and moisture. The ease of the Body mounted version was an improvement. We have been using Axon for 7+ years and currently have the Body 3. We are due for an upgrade to the Body 4 in the next few months as part of the current 5-year agreement.

The camera is only part of the solution. As you mentioned, other considerations include storage, discovery, and records requests (FOIA). Right now many agencies in the State use Axon and the troopers (I hear) are considering adopting them in lieu of the current Motorola cameras. Additionally, the Department of Law may soon begin using Evidence.com (Axon) instead of NICE, which is their current digital evidence management solution. This would make it much easier to share recordings and other digital evidence with Law. While the State may or may not ultimately adopt Axon, I can tell you from a user perspective that Axon products are very intuitive.

The digital evidence management portion of Axon is Evidence.com. We save all digital evidence in Axon with few exceptions (large cell phone extractions and heavy video files over 4 GB). It's easy to create a case and upload all reports, photos, video, and documents. Each officer has a department issued smart phone and the Axon apps which allow them to take photos, video, recordings, or even send links to citizens who can transfer their own photos and recordings to the officer similar to Dropbox. The body camera needs a smart phone. Not sure if Sitka currently issues them, but that would be a consideration. It also replaces the need to buy other cameras or recorders.

There are policy considerations, record's retention schedules to consider, limits to body camera recordings, and differences between camera recordings and human memory that should be evaluated. Pixel resolution, frame rate, refresh rate, and angle all affect the camera recordings. For example, the human eye closely replicates about 24 frames per second and a 55 mm view. Most body cameras record at 30 frames per second and some have a 120+ mm view. Body cameras record a field of vision, they do not capture the officer's perspective, focus, interest, or intent. Cameras don't have emotion, experience stress, or get fixated on objects. In other words, viewing footage can add information to an officer's memory through perception, so deciding whether or not to allow them to view footage before completing a use

of force report is an important policy consideration.

I'm not in the office right now, but I would be happy to share our SOP. I am a huge proponent of body cameras. Even the few officers we have that worked in the digital recorder days would never want to go back. Other benefits with certain cameras and manufacturers include technical capabilities like "live streaming" critical incidents from cameras to a command center or EOC, geolocating or mapping an officer's location in CAD or through RapidSOS, and automated translation and transcription.

Kodiak uses 18 body cameras. We equip all the police officers, community service officer (code enforcement/animal control), and 2 corrections officers who conduct prisoner transports with them. We are paying about \$18k a year right now. Other services like those mentioned above would add a cost to the current plan.
