VI. APPROVAL OF MINUTES

A. Approval of September 13, 2023, meeting minutes.

M – Stevenson moved to approve the September 13, 2023, meeting minutes. Motion passed unanimously.

VII. REPORTS

Harbormaster – Eliason stated that ten boats were seized, and the owners were given a thirty– day period to address their issues.

IX. NEW BUSINESS

C. Update from the Tourism Task Force Representative

Scott Wagner provided an update on the Tourism Task Force, indicating that their meetings have commenced, although with limited progress thus far. Recent petitions, particularly the latest one, have generated increased interest. He mentioned that he was a member of the regulations permitting subcommittee working group, and their discussions in several meetings have focused on delineating specific roles and refining permitting processes associated with cruise ship passenger tourism within the city.

D. Discussion on the Appeal of Stall Cancellation

The Commission deliberated on the stall cancellation procedure. Gordon questioned whether letters were dispatched to both the user and the process. Eliason clarified that notifications were sent exclusively to the user. He expressed a desire for a revamp of the process concerning this issue. Peeler expressed surprise that this was part of an ordinance and remarked that if a user was meeting their invoice payments, they should not face cancellation.

Peeler moved to approve the appeal on the stall cancellation. Motion passed unanimously.

E. Discussion on Stall Nonuse

Stan Eliason Harbor Master provided a background on this item. The Commission deliberated on the requirement for boats to utilize the stall within a 90-day calendar year. Peeler and Eliason questioned the rationale behind making it challenging for users who are already paying their moorage fees to operate in Sitka. Stevenson inquired about the historical context of the code that mandates such a provision. Stevenson also raised concerns about the 30-day notification process. The Commission recommended that staff consider incorporating fisheries into the discussion.
