HARRIGAN CENTENNIAL HALL COMMERCIAL OPERATOR PARKING SPACES PERMIT 2022

Up to five outfitting spaces may be designated and assigned to commercial operators for the purposes of accommodating vehicles that are necessary for customer outfitting and rental of equipment to be used on a trip or tour. The annual cost of the nonrefundable parking permit will be \$500.00. Those businesses awarded space under this provision may remain overnight to reduce congestion.

Limitations:

1. Permittees may park from April 15th – October 15th of a calendar year.
2. Vehicles are to be necessary for customer outfitting and rental of equipment to be used on a trip or tour.
3. Designated areas for this parking space are set out in Attachment 1. Designated areas will be 25 feet long / 10 feet wide / 9 feet high. Designated areas will be marked or established with the boundaries by paint markings. Trailer and tongue must not exceed these dimensions. All staged equipment must remain within designated areas.
4. Businesses permitted to occupy these spaces will be allowed one sidewalk space at Harrigan Centennial Hall/Crescent Harbor for solicitation or freestanding, portable or mobile signs. All solicitations, negotiations and executions of sales shall only be conducted in the designated sidewalk space.
5. Permits issued are contingent on a permit application being accepted and fees paid. Spaces will be assigned by the Harrigan Centennial Hall Manger.
6. Additional parking spaces may be designated if space is available. An additional fee of five hundred dollars per parking space will be assessed to those businesses receiving an additional space. No more than two parking spaces will be rented to any commercial operator under this provision.

HARRIGAN CENTENNIAL HALL COMMERCIAL ADVERTISEMENT SIGN REGULATIONS 2022

Persons intending to place any commercial advertisement sign in the Harrigan Centennial Hall Plaza and O’Connell Bridge Lightering Facility areas shall first be required to submit a Harrigan Centennial Hall Permit to Sell. Upon approval, you will be allowed one sidewalk space at Harrigan Centennial Hall Plaza/O’Connell Bridge Lightering Facility on a “first come, first served” basis, for solicitation or freestanding, portable or mobile signs.

Limitations:

7. Permittees may conduct business from April 1st to December 31st in a calendar year.
8. Any signs used by permittees in an area regulated by this chapter must be in compliance with the law. All signs, vessels and vehicles must be portable or mobile and must be removed from any area for which the City and Borough is responsible at the end of the business day.
9. Freestanding signs will be limited to one per permittee at each location and shall not be more than three feet wide and four (4) feet from the ground and shall only be posted in the “designated areas.”
10. All solicitations, negotiations and executions of sales shall only be conducted in the designated sidewalk space.
11. Permits issued are contingent on a permit application being accepted and fees paid. Spaces will be assigned by the Harrigan Centennial Hall Manger.
